President Pam Williams called the meeting to order at 10:00 a.m.

Approval of the Minutes: The minutes of the September 14, 2022 Board meeting and the September 28, 2022 General meeting were approved as presented.

Approval of the Treasurer's Report: Treasurer Margie Barber read the Treasurer's Report as of October 12, 2022. Dues revenue as of September 14, 2022 was \$1,000.00; Expenses were \$334.86; Revenue over Expenses was \$665.14. The Treasurer's Report was approved as read.

Committee Reports:

- Membership/Communication Chair Dick Sussman reported that the QCGC now has 70 dues paying members. Anyone who has paid their dues as of October 1st is automatically paid through December 31, 2023. Regarding Communications, Dick reported that he has made 15 important additions to the Club's website and urged the Board members to check them out. He will also send out e-mails to members about various genealogy information on discount opportunities no more than twice a month and which includes our club disclaimer.
- Education Chair Mary-Lynn Dubray reported that she is still working on getting her committee together. She is hoping that some of our new members are "advanced" genealogists. If so, please pass their names on to her so she can talk to them about joining her committee.
- Due to Program Chair Janice Messer's absence, Mary-Lynn Dubray reported that she will be the speaker at our October 26, 2022, General Meeting. Her topic will be "Genealogy Tips: Loving Ancestry's Leaves but Avoiding the Rabbit Holes."
- Social Events Chair Bobbi Gordon's report on the November 2nd Social Event will be addressed under New Business.

Old Business:

• A discussion was had about the distraction caused by having people bring their computers to the meeting and trying to follow the speaker's talk at the same time.

It was decided that computers will not be encouraged at future meetings. Handouts will be encouraged.

New Business:
