## Minutes of the QCGC Board Meeting of January 11, 2023

President Pam Williams called the meeting to order at 10:00 a.m.

**Approval of the Minutes:** The Minutes of the December 14, 2022 Board Meeting and the January 4, 2023 General Meeting were approved as presented.

**Approval of the Treasurer's Report:** Treasurer Margie Barber reported that we should refer to her report as of December 31, 2022 given and approved at the General Meeting on January 4, 2023. She suggested that in the future, since the new date of the General meetings has been changed to the first Wednesday of the month, she would prepare the Treasurer's Reports as of the last day of the preceding month and present them for approval at the General Meetings.

## **Committee Reports:**

He has left a message for a member on the Board of the Southern AZ Genealogical Society (SAGS) to find out if they may want to join us in coordinating a trip. So far, he had not heard back from them. He suggested that January or February 2024 would be a good time for this trip since it is likely to be less crowded there at that time. He also mentioned the Temple Square Hotel near the Library as a good place to stay.
