## **Committee Reports:**

• Communications/Membership: It was suggested and agreed that this committee be divided into two separate committees. It was moved and seconded to make these changes. We will need to appoint a permanent membership chair.

• Guest Speakers: Committee Chair Janice Messer was not present at this meeting. A suggestion for the December General Meeting was for members to share Holiday Traditions from their own families.
